- IV. UT Budget and Diversity Funding
 - a. Background: In the week prior, the Senate Education Committee voted to add an amendment to UT's budget that would remove the funding for the Office of Diversity & Inclusion ("federal funds only" when the Office does not receive any federal money) and use it for agricultural extension work in rural Tennessee counties.

 - b. What can we do?
 - i. UT is committed to the office remaining intact and open.
 - ii. The budget will next go to the Senate and House's respective Way and Means Committees. Contacting your legislators is a good place to start.
 1. Discuss why the passage of this will affect you, why the Office of Diversity and Inclusion matters to you, the wide variety of "diversity" (rural students, veterans, first-generation college students).

 - ii. The Coalition of students organizations have issued demands that include that the gender-neutral pronoun article is posted online again, but the Chancellor's office has said that will not happen and has not apologized.
